BACKGROUND INFORMATION FOR NEW BUSINESS ITEM 5.1

BILL 6 -The Accessible BC Act. Lack of Inclusion of Dyslexia (See background information attached) – Anders Lunde

You may have heard of Bill 6, The Accessible BC Act. I have included information from Dyslexia BC/Cathy McMillan with concerns around Dyslexia (and consequently, Learning Disabilities/Specific Learning Disabilities). I am hoping this is something which can be discussed at our DPAC meeting next week and my hope would be that some sort of letter could be sent, at minimum, to our local MLA, former SD33 school board chair Dan Coulter, who serves as the Parliamentary Secretary for Accessibility.

FROM DYSLEXIA BC (CATHY MCMILLAN)

You may have seen on Facebook that Global BC asked for me to come on the News tomorrow (live) at 8:20 am with Jennifer Palma. I'm sure it will be played throughout the day, but if not, I am mainly going to talk about the fact that the new BC Accessibility Legislation does not mention Learning Disabilities or Dyslexia which means that most likely LD will be interpreted as not being included even though it is. In the Federal Legislation for Accessibility "Learning" is included as an "impairment" or disability!

I will only be on for 4 minutes....but I plan on talking about the New BC Accessibility Legislation and the impacts on LD including Dyslexia, the meeting with the Minister of Education - Jennifer Whiteside on April 6, 2021, maybe the fact that the Federal Government has decided to defund CELA and NNELS which are the national audiobook providers for the print disabled (including dyslexia) and last but not least the fact the BC Psychologists would like to get coverage under MSP or APP and relocate into medical practitioner offices.

I need you to help with advocacy!!!!! As soon as you can! (I'm not sure when the BC Accessibility Legislation Bill 6 will be voted in)

1) Send a letter to your MLA saying that LD/Dyslexia need to be explicitly included in the BC Accessibility Legislation - BILL 6 and explain to them that you would like this brought up before Bill 6 becomes law! If you want to attach a letter that I made to make this easier please do!! Your MLA will want to have your address including your postal code, in your email, they will answer faster!

1. CALL TO ORDER – Zoom

1.1 Call to Order

- Michelle McGrath, Chair, called the meeting to order at 7:04pm
- Qurom of 10 voting members met with 16 DPAC members present

1.2 Adoption of the Agenda

1.3 Approval of the Minutes

2. Special Presentation – Summer Learning, Principal Sean Wicker

- Brochure will be available May 3 with registration opening that day around 3pm through the 3rd week of June.
- Mass email will go out.
- Posted on SD33 website, Summer Learning has its own tab.
- Teachers covering multiple courses.



- Goal is to do everything in person.
- Admin will look at all registered students with IEPs, will see what each class needs, to figure out EA support.
- Elementary is built around 4 hours a day, over 2 weeks for a total of 40 hours. This could be a challenge for working parents.
- Trying to keep class size around 18, a manageable level.
- A teacher can refer a child but referral is not necessary.

Sean Wicker and Joe Massie leave the meeting.

3. REPORTS

Trustee Report – David Swankey

- Michelle asks, how is consultation with the school community happening? That is a
 question for the board, David hesitates to speak for them. In regard to next steps, June
 30th reporting deadline, Board has not taken steps. Best to email Willow to ensure
 community pieces are not dropped.
- Anders asks if the Board is relying on experts for the definition of Inclusion.
- Heather, is the board advocating the ministry for more funding? (bussing). David has
 brought forward two motions that have passed regarding special interest money for
 institutions, the other was related to Covid funding. There is more voice that the Board
 should be using for advocating for more funding to ensure student success and
 outcomes.
- Alicia asks about the BCSTA motion that went forward around Restraint and Seclusion. David asks if there is a question or looking for a summary. Summary. There was a motion that came from Langley School Board around eliminating restraint and seclusion. The discussion on the floor went many ways. What it touched upon was that nothing stops the board from bringing it up on their own, but boards like autonomy to decide things locally. It's difficult to have this conversation with over 60 boards represented. Attention and discussion around a topic which should be discussed. Alicia asks if this should be brought to the Inclusive Ed committee? David says there needs to be a place to review these discussions, board needs to be well informed, staff needs to be aware of outcomes, what is the role of the committee, which is in flux.

Chair's Report - Michelle McGrath



- Last week our DPAC Executive met to discuss our votes on the resolutions being presented at the upcoming BCCPAC AGM. In the interest of time, we will not be reviewing the resolutions this meeting, however if any of you have questions relating to the resolutions or would like to know how DPAC is voting on a specific resolution Diane and I can stay on at the end of the meeting to discuss with you.
- On Tuesday April 6th the Minister of Education released the finding of the Special Advisors appointed to evaluate the Board of Education. The minister has directed the board to take the following steps by Oct. 31, 2021:
- review and revise its policies and codes of conduct for students to ensure they promote a safe, welcoming and inclusive school environment;
- establish a plan for enhancing student achievement, with a focus on inclusive education, children and youth in care, and Indigenous students;
- develop a policy regarding inclusive board practices after considering input from the school community;
- review and revise its Code of Ethics for Trustees after obtaining and considering input from the school community;
- work with the Office of the Human Rights Commissioner to arrange and participate in training; and
- collaborate with local First Nations to develop policies and procedures that allow for meaningful engagement with Indigenous community members.
- To demonstrate progress on these expectations, the board will submit reports on June 30 and Oct. 31, 2021, updating the minister on the status of addressing her concerns.
- McKay, who has served in multiple roles in B.C.'s education sector including as principal, superintendent, official trustee and special advisor, will continue in his role as advisor to support the board and evaluate its progress in meeting the expectations the minister has set.
