- 2.1. Trustee Report David Swankey
  - Gave an update on Board dealings since May meeting

- Board meeting structure has changed a bit. Earlier time, one 10 minute break and more opportunity to flush out questions at Learning Sessions before public meetings. Trustees have also reinstated written Trustee reports.
- 2021/2022 Budget has received a 2<sup>nd</sup> & 3rd reading
- The board has passed the 5-year capital plan with the updated Mission, Vision and Motto and can be found on the District Website
- Enrollment is 500 students higher than budgeted for but with more students also comes more funding from the Ministry

  - It aims to work with partner groups to work on bias in the community, not just schools
  - The committee has an upcoming meeting with the school district

- 2.3. BCCPAC Report Meghan
  - The basics and structure of PAC/DPAC/BCCPAC were explained and how they work together and support each other
  - BCCPAC is looking for parents to attend Ministry feedback sessions on Distance Learning as there are plans to change this programming. Email dpacbccpacrep@sd33.b.ca for further information
- 2.4. Treasurers Report

    - Gaming account balance, after commitments \$5389.74
    - o General account balance, after commitments \$2006.92
- 2.5. Chair's Report
  - Members from the DPAC Exec attended a partner meeting with the Special Advisor, Mike McKay, to discuss Inclusive board practices.
    - It was a large group, and difficult to participate in a meaningful way therefore DPAC will submit a follow-up email
  - DPAC hosted Suzanne Perrault who provided parents an presentation regarding IEPs. If parents missed the event she will be doing another presentation in October. The link will be posted in the DPAC event when available.
  - FSA's will be rolling out again this Fall.
    - Parents should know they have every right to opt their child out of writing the FSAs without retribution or exclusion from education time. If parents are asked to remove their child from school during FSA's and need additional support DPAC can help provide support.
  - Staff who are unable to wear a mask are being accommodated by using other safety measures, such as physical distancing and barriers
  - Teachers K-3, at the request of parents, will support your child to wear a mask
  - This is a bargaining year for teachers



- Let's Talk SD33 has been created on the district website and provides information and opportunities for feedback. DPAC is accepting feedback on ideas to provide to the district to utilize this platform.
- DPAC provided feedback to the district on the draft childcare policy which will be sent to EPAC for further review
- DPAC inquired upon the status of the Equity scan in the district which is continues to be ongoing.
- The Hybrid program did not garner enough interest to run at the elementary level however one class is running at CMS and VMS
- DPAC asked the district about details for the Cross Campus program for secondary students which is designed to offer students the opportunity to access select classes at other schools, more details will come next month
- Saleema Noom's Parent information presentation is booked for March 8<sup>th</sup> from 630-8pm
  - DPAC is offering to fund the opportunity for 2 classes at 2 schools to access Saleema Noom's programming in school, in addition to an additional parent workshop. Coordination for this would need a parent to gain approval from their school admin and a teacher. Please let DPAC know if you are able to arrange this as soon as possible as Saleema's schedule fills up quickly.
- The Rotary Club organizes an annual fundraiser for A Children's Right to Play which donates money for inclusive play equipment in school playgrounds. DPAC has agreed to hold the funds from the Children's Right to Play fundraiser in trust until a PAC recipient is announced for the next project.
  - The list of schools on the playground repair or replace list the District submits to the Ministry to request funding changes from year however DPAC is not consulted on the list so the reasoning is unclear
  - If PACs feel that your school should be on the list submitted annually from the District to the Ministry for funding please advocate to your school admin. PACs are not responsible to fund all playground equipment, DPAC can help provide further guidance and information as needed.

- **3.1.** Transmountain Pipeline Expansion
  - The CER ruled to approve Transmountain's proposed route
  - DPAC filed a letter asking the CER to correct discrepancies between the ruling and Transmountain's plan

- DPAC has communicated to District the need for Emergency plans specific to the pipeline for schools within close proximity
- We are looking for parents from affected schools to join a possible TMP committee to facilitate communication on parent concerns between PACs and school administrators. Please email DPAC with any interest

- 4.2. Stitó:s School Boundary Review Megan
  - The public can ask questions, make comments and find information at https://www.letstalksd33.ca/boundary-review
  - The new school, Stitó:s, is scheduled to open for Fall 2022 for K-8 students
  - The District is redrawing catchment boundaries for all levels of schools in the area to balance the student population as equally as possible which is a very complex and difficult process
    - The Stitos school is built on traditional and unceded territory of the Soowahlie but Soowahlie students are not included in the catchment as it is currently proposed and would be bussed to other schools
    - There is was a zoom consultation on Sept 16<sup>th</sup> and there is an in person consultation at MSMS on Sept 23<sup>rd</sup>
- 4.3. Summer Learning Consultation
  - Sean Wicker is scheduled to present on Summer Learning in October and will accept feedback and answer questions
  - DPAC Reps are asked to take these questions back to their PACs for consultation and bring back feedback at the DPAC October general meeting:
    - o Is your child able to attend summer learning?
    - If not, what is the barrier to your child attending?
       (Dates/Times of the programming, location, child not accommodated for diverse abilities etc.)
    - If your child has attended, what was positive about the experience?
    - If your child has attended, what do you feel could have been improved?

- 4.5. Roundtable on the changes to the Public-School Board Meetings
  - Changes in how these meetings are run were announced at the September Board meeting. The changes are a trial and open for feedback from the public
  - The changes include:
    - The Super Intendent screening questions and deciding if they are operational questions prior to the Chair reading them out. Questions deemed operational are answered via email by the Superintendent.
    - A 10-minute is scheduled in the meeting.
    - o An earlier start time at 530pm instead of 7pm
    - o Presentations will not be in the same format as before
    - o Feedback:
      - The new format makes for a faster meeting
      - In-person it would be difficult to attend at the 5:30pm time. The new time is a barrier to some having dinner or attending activities
      - The break is possibly a good tool for some of the Board members but maybe not always necessary
      - The presentations at the meetings were beneficial and informative for the public
      - A covid update was not on the agenda of the last meeting and therefore creating the inability to comment or ask questions on the subject publicly
