

#### **Bur** context

The Chilliwack School District is the eighth largest school district in the province, with just over 14,506 students and approximately 2,500 staff members. We have formed an Accessibility Committee to advise the organization on our accessibility plan. The plan includes identifying, preventing, and removing the barriers to accessibility that people lace within the school district. Accessibility needs are unique to the community, thus understanding the Chilliwack School District story holds the key to understanding how we address the needs.



#### Principles Guiding Our Work

The Accessible BC Act incorporates a set of principles that organizations must consider when developing their accessibility plans, ADAPTABILITY, COLLABORATION, DIVERSITY, INCLUSION, SELF-DETERMINATION, UNIVERSAL DESIGN

#### Our Framework

To systematically identify, remove, and prevent barriers within our environments, the District commits to exploring the five Rey standards:

- employment practices hiring policies, practices, and accommodations to ensure equal opportunities for individuals with disabilities.
- delivery of services educational programs, cutriculum, and teaching methods to accommodate diverse learning needs and provide inclusive education to all students.
- built environment audit facilities and make necessary modifications to ensure physical access for individuals with disabilities.
- information and communication entails ensuring that all District communications, including websites, documents, and multimedia, are accessible to individuals with disabilities.
- transportation accessibility, considering the needs of students, staff, and community members with disabilities.

# ACCESSIBILITY

Chilliwack School District

The Accessible Canada Act (ACA) aims to create a barrierfree Canada by 2040 and highlights the necessity for laws, policies, programs, services, and structures to consider the diverse disabilities individuals may have, their interactions with the environment, and the various forms of marginalization and discrimination they may face.

#### Accessible British Columbia Act Overview:

- The Accessible British Columbia Act came into force September 1, 2022
- Applies to school districts as of September 1, 2023
- Aim is to increase all persons' ability to meaningfully participate in their communities by attempting to remove barriers through the development of accessibility standards.





## Definitions in the Act:

- Disability
  - An inability to participate fully and equally in society as a result of the interaction of an impairment and a barrier.
- Barrier
  - Essentially, anything that stops those with disabilities from being included.
  - Specifically, anything that hinders the full and equal participation of a person with an impairment.
- Impairment
  - A physical, sensory, mental, intellectual, or cognitive impairment which is permanent, temporary, or episodic.
  - (Episodic disabilities are life-long conditions, such as diabetes, HIV, Cancer, and Multiple Sclerosis for which there is no cure and some days are better than others. People living with episodic disabilities experience periods of fluctuating good health and ill health and rely on proper care, monitoring and treatment)

# Requirements for School Districts:

- Create an accessibility committee to assist in identifying barriers and advise how to remove or prevent the barriers
- Develop an accessibility plan to identify, remove and prevent barriers
- Establish a process for receiving public feedback on the accessibility plan and identification of barriers to accessibility

# Accessibility Plan:

- Identify, remove and prevent barriers within the District and for those who interact with it
- Must be reviewed and updated at least once every three years
- Must consult with the Accessibility Committee in developing and updating the plan

### Inclusion

- Refers to the idea that everyone in the District should have the same opportunity to participate in every aspect of life to the best of their abilities and desires
- Requires an understanding of the relationship between how people function and how people participate in society



### Adaptability

 Refers to an institution's ability to adjust quickly to changes in the physical and social environment

#### Diversity

Refers to an understanding that each person is unique and brings with them a unique heritage, perspective, and set of lived experiences


Disability is one aspect of diversity



#### Collaboration

• Means the action of working collectively, or together with a group, to produce or create a final product






## Self-Determination

 Refers to an individual's entitlement to freedom, authority, and supports to exercise control over their own life

#### Universal Design

• Refers to the process of creating products that are equally accessible to all, or at least a wide range of people who have differing abilities, disabilities, and other characteristics






