2.1. Chair Report

- Short month and we did a lot!
- Advocacy letters that were directed by the membership last year went out to the provincial level.
 - FSA Advocacy – Advocating for the District and province to recognize parental authority to withdraw consent to write the FSA without pressure from principals.
 - EA Advocacy – Advocating for the Provincial government to address the lack of standards of practice, training and support for the EA's through researching the problem and establishing standards.
- DPAC attended another intense School Board meeting where good and important work District work was interrupted by protestors against SOGI 123 because misinformation continues to circulate.
 - SOGI 123 are researched and proven tools and resources from the provincial government regarding SOGI-inclusive policies and procedures, environments and curriculum resources.
 - Please educate yourself and your PAC with the facts. If you have further questions as your child's teacher or school principal.

- DPAC continues to take strides towards reconciliation.
 - In partnership with the Indigenous Ed Dept, we hosted another BC Blanket Exercise. It was an evening of powerful learning and I was again honored to learn and witness the truths of Canada's History.
 - The District invited us to represent the parents at their Journey to Truth and Reconciliation professional development day. It was a powerful day with Len Pierre, Dr. Keith Carlson, and local Chiefs teaching the entire 2500 District staff together.
- PAC Café took place last night and was extremely successful. Parents enjoyed



dinner, information about best practices for PACs and great conversation regarding what is happening across the District. We hope to do this again, but with a different twist.

3. UNFINISHED BUSINESS

3.1. Ongoing Advocacy Efforts

- Learning Environment Temperatures
 - Vents are being installed in portables for portable AC units.
 - Principals have to advocate for AC install in portables.

- Bussing
 - Will meet with Superintendent on October 31 to discuss.
 - Some students still don't have bus passes.
 - Staffing – short on bus drivers so routes are being heavily impacted.
 - System glitches created a scenario where >1000 students weren't registered for bussing until after Labour Day.
 - For now, we just want to ensure that people who need busses get them.
 - Advocacy ideas:
- 3.2. Advocate to the Province for increased city bussing?
- District Partnership Conversations:
 - Hiring perks and wider reach
 - Better plan for next year is needed.
 - Can a hiring event?
 - How much is the training?
 - Job posting is confusing and some don't understand what exactly is required.
 - Out by Cultus, some families don't have cars.
 - Equity issue around food accessibility bc some students are late and are missing the breakfast program.
 - EA Supports
 - DPAC had a meeting with HR to better understand what training District occurs and what "equivalent" means in the job posting.
 - Fundamental issue is the District feels that 3 days of onboarding and 3 days of shadowing is sufficient to support diverse needs and parents don't.
 - DPAC will bring up the District Administration Policy that doesn't allow for District staff to work with the same students from their site after hours and off school property. Exemptions are possible.

 - Playgrounds
 - DPAC doesn't have capacity for a committee right now but will continue to advocate to the District.
 - Wheelchair accessibility would be very nice. For children in wheelchairs and for parents in wheelchairs.
 - McCammon almost two years ago started advocacy for inclusive playgrounds. Approached habitat to get an audit to see what equipment could be used to amplify this. Two years in, they still haven't had anyone in to do this assessment. Seems to be a bottle neck to get advice for what is needed. We need to enhance



- availability of these resources to speed up the process.
 - Stitos and promontory have inclusive playgrounds.
- 3.3. Affordability Fund
- Can only be used for school supplies this year, but creative thinking can really expand the scope beyond traditional school supplies.

 - Mt. Slesse has a volunteer program for students to stay after school to bake for the breakfast program the following morning.
 - Cereal drive to get a lot of cereal for the school.

Chilliwack Healthier Community (CHC) is comprised of 52 member organizations that collaboratively work to implement the CHC Strategic Plan, through the following action-oriented committees.

CHC STEERING COMMITTEE

The Steering Committee has two main functions:

1. Organizational Structure: ensures alignment of CHC work with the CHC Strategic Action Plan; guides growth of CHC partnerships
2. Measurement and Monitoring: collects and summarizes data to support the work of CHC and measure outcomes; ensures partner expectations are met; and reviews the annual budget and financials.

HEALTHY AGING TASK TEAM

The Healthy Aging Task Team supports older adults in Chilliwack by increasing awareness of existing services and supports, and developing solutions to identified gaps and emerging issues.

Accomplishments to date: Supports for Seniors Quarterly Resource Sheet • Seniors Resource Card • Every Door is the Right Door for Seniors • BC Seniors Week Expo • Adult Abuse Prevention Community Forum • Advocacy for improved transportation for older adults

HOUSING FIRST TASK TEAM

The Housing First Task Team is a collective of front-line service providers who offer shelter spaces, low barrier housing, low-income housing, and services for individuals experiencing or at imminent risk of homelessness. The objectives of this team are to identify challenges and support the development of solutions in real-time to ensure full wrap-around services, and support initiatives to increase the supply of affordable housing based on local housing needs.

Accomplishments to date: Housing First implementation in Chilliwack • Supported development of Housing Hub model • Helped establish the City of Chilliwack as a Community Entity for the Federal Reaching Home Program • Resources and Services Card • Assisted in development and implementation of the Chilliwack Homelessness Action Plan •

OPENING DOORS TASK TEAM

The Opening Doors Task Team welcomes opportunities for service providers and community members to learn and share about the history of First Nations, Metis and Inuit people, and Truth and Reconciliation work. This builds a community of belonging, positive relationships and partnerships, and increases engagement with all communities in a culturally safe way.

POVERTY REDUCTION TASK TEAM

The Poverty Reduction Task Team engages in strategies to address poverty in Chilliwack through data collection and the promotion of poverty reduction programs in the community. In 2023-2024 this team will participate in the development of a multi-sectoral community-based poverty reduction plan.

Accomplishments to date: Poverty and Chilliwack Report • Poverty Storybook • Co-chair the Chilliwack Financial Literacy Committee • Creation of Chilliwack Food Council to address Food Security • Collaboration on the creation of the Downtown Chilliwack Community Market model

CHILLIWACK FOOD COUNCIL

The Chilliwack Food Council works to ensure equitable, inclusive, sustainable, and culturally appropriate access to food in Chilliwack in the short, medium and long term.

Accomplishments to date: Free Food Programs in Chilliwack Inventory • Food security survey • Chilliwack Community Food Hub • City Wide Gardening Project inception • Downtown Chilliwack Community Market, a food security initiative

SEXUALITY AND GENDER EQUITY COLLABORATIVE (SAGE)

The SAGE Community Collaborative creates and promotes education and awareness opportunities for service providers, to ensure that individuals of all sexualities and genders are served equitably.

Accomplishments to date: Gender 101 and Gender 201 webinars

SHORT-TERM WORKING GROUPS

Immediate concerns identified during the 2023 Strategic Action Plan engagement sessions resulted in two short-term working groups: Strengthening Services and Supports Working Group; and the Substance Use Continuum of Care Working Group.

The Strengthening Services and Supports Working Group works with partner agencies and individuals with lived experience to identify and improve service navigation.

The Substance Use Continuum of Care Working Group focuses on the local requirements and needs of individuals experiencing substance use challenges and/or at risk of substance poisoning. These include prevention, diversion, detox, treatment, and aftercare.

Accomplishments to date: collaboration with Fraser Health to streamline common language and clarify the process for individuals seeking access to detox and treatment.

To whom it may concern:

On behalf of the Chilliwack Healthier Community partnership, I am pleased to write this letter of support for the Chilliwack Youth Health Centre (CYHC) in their application to become a Foundry.

The CYHC has a strong history of providing low barrier, on demand medical and mental health services for young people. CYHC has multiple partnerships and relationships they can leverage to build a wrap around system of care for some of our most vulnerable youth and those struggling with mental health or addiction. It is well positioned as a first stop care center for youth. CYHC is one of the few youth focused agencies with an integrated medical and counselling services that spans the critical age when young people move into adulthood. Traditional youth services often go only 12 to 18 with a distinct break between those 19 and up. The CYHC is open to young people who are moving between these population groups, often at time when they are extremely vulnerable.

We've participated on committee work with the Chilliwack Youth Health Centre (CYHC) since 2014, when CYHC representatives first become involved in a Mental Health Awareness committee hosted by us. Examples of two activities from this collaboration were a public forum on Mental Health and Addictions and the creation of the Elements of Mental Wellness Guide.

We support the continued work of CYHC by raising awareness of their services and priority to meet the needs of Chilliwack youth, and promoting and working with them in community events.
